***The Rae Estes BBQ Cook-off will follow the rules of the Outlaw BBQ Association.***

***You do not have to be a member to enter.***

- Cookers may begin setup on Friday, October 23<sup>rd</sup>, from 4:00 p.m. to 7:00 p.m.
- Minimal security will be provided. The San Augustine County Chamber of Commerce and San Augustine County will not be responsible for losses resulting from theft, damage, or accidents.
- Each cooking team is responsible for the clean-up of their area. Hot coals or ashes must not be put in the trash cans or left on the ground. Each cook team must provide its container for hot coals and ashes.
- The head cook is responsible for his/her team and guests.
- The team will be permitted to sell BBQ to guests of the festival.

***However, competition meat cannot be sold until after judging.***

The Texas Department of Health Services may be at our Festival checking for Retail Food Establishment permits and will, unfortunately, immediately shut down vendors who do not have a copy of the permit with them. Also, please be aware that food may not be prepared in a home kitchen and then brought to the festival for serving by must be prepared in a commercial-type kitchen at a church or school, or prepared entirely on-site at the festival itself. Temporary permits cost \$52 and should be requested as soon as possible to allow time to process your application. Please ensure that you have your Retail Permit with you on the day of the festival – no refunds for missing permits.
